THE STATE of SOUTH-CAROLINA. To all and singular the Sheriffs of the said State GREETING: You, and each of you, are hereby commanded, without Delay, to attach the Body of

Richard Shaw otherwise call'd Richard Shaw of Georgetown in the State aforesaid

wherefover he may be found, within your and each of your respective Districts, so that you compel him to be and appear before the Justices of the said State, at the Court of Common Pleas, to be holden at Charleston, on the Second Tuesday, in September next, to answer to

Lewis Dutaque otherwise called Lewis Dutaque of the said Town & State aforesaid, in a plea of Debt that he render unto him Eight Hundred pounds of Sterling which to him he owes & from him any other claims & of all

And have you then and there this Writ.

WITNESS the Honorable Thos Heyward Junr one of the said Justices at Charleston, the 10th Day of July in the Year of our LORD One Thousand Seven Hundred and Eighty- and in the 10th Year of the Sovereignty and Independence of the United States of America.
