

SPRING TERM will commence Wednesday, April 5, 1871.

The College Year will close with Examination and Exhibition, June 21 and 22, and commence October 11, 1871, with an efficient Board of Instructors. Students should be present the first day, if possible. There will be four

Departments in the University:

THE COLLEGE PROPER,

Where the usual four years' course of College studies will be pursued, under able Professors, and Diplomas awarded to those who complete the course. The usual preparatory studies will be required.

NORMAL DEPARTMENT.

Studies and Lectures, especially adapted to training teachers of both sexes, and fitting them for their responsible work, will be pursued.

Persons to be admitted to the Normal Department must possess a good moral character, and be able to read and write well.

BAKER THEOLOGICAL DEPARTMENT.

The "Baker Theological Institute," removed from Charleston, constitutes this branch of the University. Members of the M. E. Church, who feel themselves called to the ministry, may be admitted to this Department on recommendation of a Quarterly Conference or their Presiding Elder. Students will be thoroughly drilled in the study of the Sciences, Theology, and Elocution, by recitation and lectures, under an experienced Professor.

PREPARATORY DEPARTMENT,

To which will be admitted a limited number of bright and promising children of both sexes, and special pains taken in laying the foundation of a thorough education.

A small charge, ten cents per week, will be made to each student for inci-

The University buildings contain 56 rooms, just put in good repair at an expense of \$2,500, and will accommodate 200 scholars. We appeal to our friends and societies, North and South, to aid us in furnishing them.

We will name rooms after any individual or church who will send us \$50 to buy furniture and bedding for it. Who will respond?

Orangeburg is eighty miles from Charleston, and one of the most beautiful, central, and healthful country towns in the State.

Sixth Session of the South Carolina CONFERENCE

OF THE

M. E. CHURCH,

HELD IN CLAFLIN UNIVERSITY, ORANGEBURG, S. C.,

DECMEBER 22D, 1870.

FIRST DAY.

The Conference convened at 9 A. M., on Thursday, the 22d day of December, 1870, in the Chapel of the University.

Bishop Simpson led in the opening services, by reading the 52d chapter of Isaiah, singing the 220th hymn, and prayer by Rev. Dr. Vincent and T. W. Lewis.

THIRD DAY.

(DECEMBER 24.)

Bishop Simpson in the chair. Rev. S. Weston conducted the opening services. Minutes read and approved.

Charleston was fixed as the seat of the next Conference, and the Bishops were requested to appoint the time as near the first Wednesday in January, 1872, as possible.

On motion, the Committee on "Privileges" were instructed to secure, if possible, such favors in railroad travel as is accorded to clergymen of other religious bodies. (See 2d page of cover.) Also, they were instructed to nominate Trustees for this Conference, to consist of six members, two to hold their office for one year, two for two years, and two for three years, or, until elections are made to fill their places.

CHRISTMAS, THE HOLY SABBATH.

Love Feast in the College Chapel, conducted by Brother Rosemond.

Bishop Simpson preached a "Christmas" sermon at halfpast ten o'clock, after which he ordained twenty-eight Deacons.

Rev. Dr. Walden preached at three o'clock, after which the Bishop ordained ten Elders.

A. W. Cummings, D. D., preached at night. The services during the day were attended with a most blessed influence.

REPORTS OF COMMITTEES ADOPTED.

CHURCH EXTENSION.

Whereas, in many of our circuits the work is retarded and embarrassed for the want of comfortable houses of worship, and as our Church Extension Society has done much, and proposes to do still more, to aid us in this direction, therefore,

Resolved, 1st, That each preacher shall faithfully present the claims of this Society to his people, and take a collection during the year.

Resolved, 2d, That A. Webster, T. W. Lewis, T. Whittier, J. C. Emerson, F. Smith, Jacob Mills, M. G. Camplin and W. D. Middleton, be appointed and constituted a "Conference Board," as required by the Discipline. (See Discipline page 247.)

MEMOIRS.

Died at his residence in Sumterville, S. C., November 13th, Rev. Joseph White, in the thirty-fourth year of his age.

Brother White was one of the young men who early sought an opportunity of connecting himself to the Methodist Episcopal Church, when in the Providence of God it came within his reach. Being impressed that God had called him to preach the Gospel, he connected himself with the Baker Theological Institute. During the few terms he had the privilege of attending this institution, he made the best of his opportunities. As the wants of the regular work were so pressing, he joined the traveling connection at the Conference held in Charleston, four years since, and was ordained by Bishop Scott, under the missionary rule, and appointed to Lynchburg Circuit. Here he labored with marked success

for two years. At our Conference held at Camden, he was admitted into full connection in the Conference, and ordained Flder by Bishop Janes. His next appointment was to the Sumter Circuit. Here he found a large and laborious field of labor, but he did not shrink from the work assigned him, but with commendable zeal went forward in the discharge of his multiplied duties. At the last Conference he was re-appointed to this field. During the latter part of summer he contracted a fever, by over-work and exposure, which proved fatal. During his protracted sickness he seemed to have but little hope or anxiety in reference to his recovery, but endured all in patient submission to the will of God. As his end approached, there seemed to be no clound to darken his spiritual prospects. He took an affectionate leave of his wife and and other friends, asking them not to weep for him, but prepare to meet him in Heaven. Thus, with an unfaltering trust in God, upon the evening of the holy Sabbath, he sweetly fell asleep in Jesus.

He was a good man, and occupied a large place in the confidence of all who knew him. He was studious, improving and useful as a preacher, attending to all departments of his work. His death is a serious loss to our Conference. He leaves an afflicted widow, other relations, and many friends to mourn their loss.

REPORT ON THE RELIGIOUS CONDITION AND WANTS OF THE COUNTRY.

The barbarism of slavery and the demoralization of war, has left the field of our ministerial labor in a sad condition—politically, socially and morally.

The religious institutions of the South are corrupted, and her garments are moth eaten. We are therefore called upon as faithful watchmen in Zion, to lift up our voice like a trumpet, and show unto the people their sins, whether they will hear or forbear.

Necessity is laid upon us to preach the truth in love, counting not our lives dear unto ourselves; and to imitate those "who, through faith, subdued kingdoms, wrought righteousness, stopped the mouths of lions, quenched the violence of fire, escaped the edge of the sword; out of weakness were made strong, waxed valiant in fight, and turned to flight the army of the aliens." Still our weapons are not carnal, but spiritual and mighty, through God, to the pulling down of the strongholds of Satan.

We firmly believe that God's great means of a righteous reconstruction in this country are religious, rather than political.

Out of Zion the true light must shine if it shine at all; and Gospel leaven is the only power that can truly leaven the body politic. Therefore we avow our determination to preach the unadulterated truth as it is in Jesus, with a faith that staggers not, believing that

"Right is right since God is God, And right the day will win."

We re-affirm our solemn conviction that the true basis of organization in State or Church is without distinction of race or color; and to pander to the prejudices of the white or black race in this regard, will displease our common Father, and bring only evil and disaster in the end.

We pledge ourselves to hold no entangling alliances with any party or organization, or accept of any political or secu-

lar office which may injure our influence and prevent our rebuking sin on account of party ties or obligations.

While we deplore the spirit of opposition among Southern people, "to the manor born," to the progress of the Methodist Episcopal Church, which they erroneously persist in calling the "Northern Church," still we give grateful thanks to God that there is evidently less bitterness and opposition than existed a year ago, and we hail with peculiar pleasure indications of brotherly love and good will from some of the chief ministers and most influential laymen of the Church, South.

We believe that, a most auspicious omen, and that, as a Conference, we do and should heartily respond to all such indications of co-operation and fellowship of every branch of the Church of Christ, and we proclaim as our motto:

"In essentials unity,
In non-essentials liberty,
In all things charity."

SUNDAY SCHOOLS.

Your committee would earnestly call the attention of the Conference to the thousands of children within our bounds. We must secure them in early childhood as members of the Methodist Episcopal Church, and then carefully instruct them in the Holy Scriptures. While faithful in the training of the children, we must remember that our old people should also be instructed in the Bible. We believe that every Methodist should seek to grow in the knowledge of Jesus Christ, as well as in grace. To the old as well as to the young, the Master has said "Search the Scriptures." Your committee, while it regards the publications of our Sunday School Union as superior to every other, they believe that some plan should be devised by which Scripture lessons may be presented in a simple manner, adapted to both old and

young, and we therefore recommend the Conference to adopt the following resolutions:

1. Resolved, That we request the "Committee on Publication" of our Sunday School Union, to provide for our people a series of Lesson Tracts, for home and Sunday School use.

2. Resolved, That we request the Sunday School Union to donate a copy of the Sunday School Journal for 1871, to each of our members.

3. Resolved, That we will present the claims of the Sunday School Union to all our congregations, and take up collections in its behalf.

4. Resolved, That we request the Board of Managers to appoint a committee on application for aid, to be collected at Atlanta, Georgia.

5. Resolved, That the Board of Managers be requested to send us, Rev. J. S. Ossander, to spend some time among us in the interest of Sabbath Schools.

Resolved 1st, That we will stem the tide of this terrible scourge of the land, by our practice and our preaching.

Resolved 2d, That "Total Abstinence" is the only safe motto for temperance men, and touch not, taste not, handle not are three essential knots in the temperance rope, if we would rescue the drunkard and save our youth from destruction.

Resolved 3d, That it is the duty of all ministers of the Gospel to organize and encourage temperance societies, for both old and young, pledging them to total abstinence from all that can intoxicate, and to do all in our power to circulate temperance tracts and papers, and enlighten the people.

Resolved 4th, That we have received with great pleasure the visit of Rev. Dr. Jackson, agent of the Congressional Temperance Society, and that we have listened with interest and profit to his elequent addresses, and to his statement of the plans and purposes of the society he represents, and we will most gladly co-operate with him or any other agent the Society may send to lecture and circulate temperance literature among the people.

REPORT ON EDUCATION.

As Christian ministers we still believe that sanctified education is essential to our healthful growth, as a Conference or a Church; therefore,

Resolved 1st, That it was a favoring providence that brought Classin University into being thus early in our

history as a Conference. We believe that God led us by His Providence, and raised up friends for us, so that the Trustees hold the ample buildings and their improvements, with the beautiful site of six and a half acres of land, without debt, at this present.

A new boarding hall has been erected the past year, which will accommodate fifty students, for which we are chiefly indebted to our friend and patron Hon. Lee Classin, of Massachusetts.

The Legislature granted an act of incorporation at its last session, and seven rooms have been furnished by societies or friends, after whom they have been named. The Methodist Freedman's Aid Society, through Rev. R. S. Rust, D. D., their efficient Secretary, has done nobly in sustaining our Professors and Teachers. We congratulate the Trustees on their success in procuring so able a board of instructors. Prof. J. Marcy, a graduate of Wesleyan University, and W. H. Crogman, of Massachusetts, were added to the Faculty at the commencement of last term, and have already made their mark as competent and faithful educators.

A piano of superior compass and tone has been donated to the Trustees, by the friends of the University in Boston.

Miss Ella Webster, a competent teacher in vocal and instrumental music, will give instruction in her department. Mrs. J. Marcy has a well drilled class in the Preparatory Department.

We look upon Classin University as our fathers did upon Middleton and Cokesbury. We believe it supplies an essential want in the present state of our work, and under God and by the favor of those whose hearts he will open, it will prove a glorious success. Your Committee offer the following resolutions:

1st. That we approve the doings and plans of the Trustees, so far as published, and assure them of our cordial support.

2ND. We will make known to the pople of our charges, the wants and advantages of this in aution, and induce the youth, as far as possible, to avail themselves of its benefits.

3RD. We will do our best to send at least one student from each circuit, even if we have to take collections to defray expenses of board and incidentals.

4TH. That we will use our influence and aid to establish and sustain public free schools throughout the State, and co-operate with School Commissioners and Trustees, and urge parents to educate their children.

N. B.—The Conference voted to raise \$3,000 missionary money the coming year, and it can be done, if each preacher will raise the amount set against his charge in the foregoing appointments. Let each Pastor set aside one Sabbath a month for missionary collections, and every leader collect a "penny a week" from each member, and every Presiding Elder fire the hearts of the people on this subject, at every Quarterly Conference.

As an incentive to exertion, T. W. Lewis proposes to give "Porter's Compendium of Methodism," or some other valuable book, to each preacher who brings to Conference the full assessment for his charge the coming year, providing the brethren who are successful will write him at least two weeks before the Conference.

Resolutions were passed thanking Bishop Simpson for his efficient services for us, and his affectionate interest in us as a Conference, and requesting the Episcopal Board, if possible, to assign him to this Conference another year, also to Dr. Fox, for his valuable lecture on "Self Culture;" to the railroad agents for reducing the fare to and from Conference, and to the good people of Orangeburg, for their hospitable entertainment.

The seat of our next Conference was fixed at Charleston, and the Bishop was requested to make the *time* of the session the first Wednesday in January, 1872, if practicable.

Conference adjourned.
