Aynor United Methodist Church

Recommendation of the Parsonage Contractor Selection Committee
November 21, 2011

The bid specifications for the new parsonage were approved by the Board of Trustees in September after approval of the project by the Church Conference. Bid Packets were made available to any contractor who wished to submit a proposal during the month of October with a deadline set of October 31, 2011 at 2:00 PM. All contractors were held to the same standards for submission. Ten contractors submitted bids by the set deadline. The selection process was developed and approved by the Trustees before the deadline and all contractors received an outline of the process with the dates for each step. Round 1 began the process with a scoring system in which each bid was judged using the following criteria: Price (50% of score), Experience (20% of score), Completeness of Bid Packet (20% of score), Insurance and Bonding (5% of score), and Character (5% of score). The identity of the contractors was concealed and members of the selection committee scored each bid independently. The contractors with the top five scores advanced to Round 2. In Round 2, the committee learned the identity of the top five contractors and discussed the bid proposals at length. The Committee reached consensus on the top three contractors. One committee member excluded himself from discussion for the third position since it involved a contractor that was related to his brother's family. The top three contractors were divided among subgroups and the references were checked and visits made to past construction projects. The committee interviewed the top three on Sunday, November 20.

We, the Parsonage Contractor Selection Committee, have prayerfully considered all the proposals submitted by contractors for the construction of a new church parsonage. We recommend that

Church Conference Report of Aynor United Methodist Church – September 19, 2011

Aynor UMC continues in its traditions of love for God and love for our fellow person. We acknowledge the difficult economic, environmental and cultural events of this past year and unashamedly profess our strong faith in Almighty God as the only source of our hope in the days to come. It is our strong desire to see more persons come to know Him as their savior as we move through the coming year, and AUMC's goal is to use its resources in ways that accomplish that goal.

Missions: "The King will reply: 'I tell you the truth, whatever you did for one of the least of these brothers of mine, you did for me.'" *Matt. 25:40* While Aynor struggles financially like so many other areas of our country, our congregation has chosen to continue its partnership with our friends in Davey, West Virginia, by sending food, clothing, linens, school supplies and small appliances. We are reaching out to our local area by offering food, shelter, financial assistance and other emergency aid whenever a need is presented, as well as participating in a community food bank.

Church Operations: A proposal has been made to build a new parsonage due to the condition of our current parsonage. Much prayer and consideration has been requested in this area, and we trust that God will make His will known to us in this endeavor. While our level of giving has decreased in 2011, AUMC has continued to meet its monetary obligations. God promises to abundantly bless us if we obey his instruction to tithe, and our failure thus far to do so reflects an unwillingness to trust God in His promise to "throw open the floodgates of heaven and pour out so much blessing that [we] will not have room enough for it." *Mal. 3:10*. Six verses later we find that "[a] scroll of remembrance was written in His presence concerning those who feared the Lord and honored His name." Let us hope that our names will be on such a scroll.

Worship: We have continued with the altered worship format begun last year. A more informal praise & prayer service is held on the first Sunday of every month during the Sunday school hour, with traditional services being held during the remainder of each month. We've enjoyed another year of music from the Adult Choir, soloists and groups of musicians for regular worship as well as on special occasions.

Organizations/Groups: While not large in number, our church sponsored groups are active.

Forever Young consists of our senior adults and meets on the third Tuesday of each month. This group alternates on a monthly basis between a meal & fellowship at the church and an outing to one of our local attractions. Group attendance averages between 15-25 persons and membership is open to anyone, regardless of physical limitations.

United Methodist Men meets at the church on the second Thursday of each month for a meal, devotional, short business meeting and fellowship. This past year AUMM hosted a Mother's Day breakfast, held a fundraiser to offset medical expenses for a church member,

helped cook for a district-wide new pastor's meal, helped with church clean-up and maintenance projects, and will host an upcoming district meeting at our church. Current membership is small but is open to any Christian man.

United Methodist Women is a service-oriented group that, among other things, tends to our shut-ins, supports youth camp projects through direct financial assistance, hosts luncheons to offset medical expenses of church members, sends care packages to our college students, and prepares meals for grieving families.

First Place is a small group of persons who have chosen to put Christ in "first place" in all areas of their lives – spiritually, emotionally, mentally, and physically. Meeting on Wednesday evenings, the group is currently using the "Women of Faith" study books and is open to anyone willing to put Christ first in all things.

We pray God's blessings on us all.

Charge Conference Report of Aynor United Methodist Church – September 20, 2010

Aynor UMC has a rich tradition of love for God and for its members, and it is our strong desire to delight our Lord with the activities of our church. We are mindful that, while we may have plans and hopes for the future, our goals must align with God's will. It is our hope that the activities delineated below have pleased Him and that we have used the resources available to us in a way that brings glory to His name.

Missions: Jesus' directive to "feed my sheep" has been honored by our congregation with its support for missions work this year. There have been two (2) trips to Davey, West Virginia: one trip to deliver school supplies to eighty (80) needy children and a second trip to provide linens, clothing, small appliances and food. Representatives of our church were privileged to participate in a community worship service and to then feed a crowd of more than one hundred (100) people. This is an ongoing relationship between our church and the residents of Davey, and we are honored to be able to help them during their time of need.

On a local level, our church partners with other churches to maintain supplies for a community food bank, provides grocery vouchers to hungry families, participates in a prison ministry to provide Christmas gifts to the children of inmates, and financially assists families with utility bills or other similar expenses as the need arises.

Church Operations: Our Trustees have taken good care of the buildings and property of the church, and we have been fortunate to have minimal repairs. This is especially good news with our current budget deficit. Tithes and gifts are erratic, and while we acknowledge the impact of the economic downturn, our failure in this area indicates a lack of trust in God's promise to provide: "Bring the whole tithe into the storehouse, that there may be food in my house. Test me in this," says the Lord Almighty, "and see if I will not throw open the floodgates of heaven and pour out so much blessing that you will not have room enough for it." Mal. 3:10

Worship: In response to suggestions, changes have been made to the weekly worship structure. On the first Sunday of every month, we now gather together for a praise and prayer service during the Sunday School hour. Additionally, we begin classes at 9:45 am and adjourn at 10:30 am to enjoy coffee, sweets and fellowship prior to our formal worship service at 11:00 am. Our regular services are enhanced by music from the Adult Choir, soloists, and/or groups of musicians during regular services as well as for special occasions such as Veteran's Day and Christmas.

Organizations/Groups: Our men, women and children have been active in their respective organizations this year enjoying good fellowship between themselves and God.

Forever Young is dedicated to providing Christian fellowship to our senior adults. Meeting on the second Tuesday of the month for a meal at the church and on the fourth Tuesday for a short trip and meal, this group truly enjoys their time spent together.

The **United Methodist Men** meet at the church on the second Thursday of each month for a meal, devotional and short business meeting. Although small, Aynor's UMM is quite active. This group strives to be role models by engaging in daily Bible study and prayer, by witnessing through words and deeds, and engaging in Christian service. The UMM supports a local Boy Scout troop, helps with maintenance of church property, provides assistance on mission trips, and even cooks for the women on Mother's Day!


The **United Methodist Women** is a service-oriented group of women who tend to our shut-ins, provide meals to grieving families, support summer camp projects with financial and culinary gifts, host luncheons to raise funds for necessary improvements to the Fellowship Hall, and host a mother/daughter tea in the Fall which brings local ladies into our church.

Our **Youth** meet every Sunday evening with an average attendance of twenty-five (25) teens from our church as well as from other local churches. They have recently renamed their room "The Carpenter's Shop" and have named themselves "Shopkeepers" (Servants Helping Other People Keep the faith). Currently sponsoring two (2) children on an on-going monthly basis through Samaritan's Purse, the youth have also committed to feed an additional child for the next year through funds raised in a 30-hour famine meant to heighten awareness of worldwide hunger.

Not content to stay within the confines of our church building, practices have begun for a puppet ministry and a choir/praise band which will be outreach programs to introduce others to Jesus. Other recent outreach activities include organizing and hosting an on-site prayer vigil for each Aynor school, handing out tracts at malls with one-on-one conversations with shoppers, and prayer walks through the community.

We pray that, during the upcoming year, we will do God's work in ways that lead others to a firm belief in Christ.

AUMC Church Council Report for Charge Conference of October 22, 2009

Our God is faithful and good, and He has blessed Aynor United Methodist Church. We have had a good year with our pastor, Tony Adams. He is a source of strength and compassion to our church and to our community. Our prayers and stated desires to the Conference for a preacher who would love us have truly been answered in Tony.

We are in the middle of a new program here at the church called "Five Practices of a Fruitful Congregation", because it is our wish to bear good fruit for our Lord. Accordingly, I will report to you on our activities using the five categories of our new program.

Radical Hospitality: While we are good at acknowledging our love for each other within these walls, it has been impressed upon us that we need to show that same kind of love to our visitors and to those outside of our church. Accordingly, we offer programs in our church that might appeal to believers and non-believers, in the hope that some will come in to join us. Some examples of these are our UMM sponsorship of a Boy Scout troop; our Little Samaritan's Group for children 1st-5th grade who often visit nursing homes or our elderly in the community; our UMYF group which consists of youth from our church as well as other; a Veteran's Day program which is well attended by veterans throughout Horry County; a tea party sponsored by the UMW which attracts local ladies and their daughters to our church; and, a Pumpkin Patch sponsored by Family Ministries which sells pumpkins to the community and provides hayrides, games and stories to local schoolchildren.

Passionate Worship: Consciously and eagerly gathering together in our Lord's house expecting Him to be present with us. We find ourselves at a cross-road on this issue. For many years we have done things the same way: grouping Sunday school classes according to age and holding morning worship at the same time & in the same general style to which we've become accustomed. As we move through our Five Practices program, we are gathering suggestions and seeking God's instruction on how we can make our worship more passionate and alive to please Him as well as draw others into this group of believers. Our largest and most recent investment has been the addition of a new organ in our sanctuary. After prayerful consideration was given on undertaking this expense, Church Council had the vision to see the potential for this organ to be used by all of our members to enhance worship in many different ways.

Intentional Faith Development: Deliberately getting to know God on a more personal basis. We offer traditional Sunday school and Sunday morning worship, Sunday evening bible study, Wednesday night bible study, United Methodist Men, United Methodist Women, UMYF, and Little Samaritans (1st - 5th grade). While we understand that every relationship with Christ is a personal one, AUMC believes that this church and its groups should increase one's desire for a closer walk with the Savior.

Risk-taking Mission and Service: While many of our groups might be considered local mission work groups since they are an outreach to local persons, our specified Mission Committee has been quite busy this year. In July, a mission team consisting of eleven (11) people took two (2) trailers of food, clothing, and linen along with thirty-six (36) baskets of food to Davey, West Virginia. A return trip in September resulted in that same area receiving school supplies.

Additionally, through this committee our church participated in Samaritan's Purse; adopted twelve (12) families through the Angel Tree Program; supported monthly food drives in conjunction with

another local church; helped pay the utility, water and/or rent bills of numerous local families; provided financial assistance for several families traveling through our area who wished to return home but were unable to afford the trip; and, supported a local member as he served on the NC State campus for Campus Crusade for Christ.

Extravagant Generosity: Being generous not only with our tithes, but with our time and our service. The membership of AUMC needs to grow in these areas. Financially, we find ourselves in a budget deficit, and we often have the same workers that give of their time and their service. It is our hope that the enthusiasm which has been building during our Fruitful Practice study will continue with this topic, as well. A real focus on Jesus' words about where we lay up our treasures will be needed, and this Council's prayer is that all of our hearts will be open to receiving that message.

We pray for God's continued blessings on our church as we strive to do His will.

Accountable Reimbursement Policy

The following resolution was duly adopted by the Church Council of the **AYNOR United Methodist Church** at a meeting held on **09/12/2011**.

Under Internal Revenue Code Section 62(a)(2)(A) gross income does not include reimbursed business expenses or adequately accounted business expense allowances for employees. Internal Revenue Service Regulation 1.162-17(b) provides that an employee "need not report on his tax return" expenses paid/incurred by him solely for the benefit of his employer for which he is required to account and does account to his employer and which are charged directly or indirectly to the employer. Further, IRS Regulation 1.274-5(e)(4) provides that "an adequate accounting means the submission to the employer of an account book, diary, statement of expense, or similar record maintained by the employee in which the information (as to each element of expenditure amount, time and place, business purpose, and business relationship) is recorded at or near the time of the expenditure, together with supporting documentary evidence, in a manner that conforms to all the 'adequate records' requirements" as set forth in the regulations.

Therefore, the **AYNOR UMC** hereby established an accountable reimbursement policy pursuant to IRS Regulations upon the following terms and conditions for **Reverend Robert Anthony Adams**.

1. Expenses deemed ordinary and necessary shall be made solely for the benefit of the church and shall be paid directly, whenever possible by the **AYNOR UMC** or indirectly and reimbursed to the person or entity who does pay the expense.
2. The church payroll person must be given an adequate accounting of the expense, which means that there shall be submitted a statement of expense, account book diary, or other similar record showing the amount, date, place, business purpose, and business relationship involved. Appropriate documents, cash receipts, cancelled checks, credit cards sales slips, and contemporaneous records must be attached to a monthly expense report. Copies of the documentary evidence and expense report shall be retained by both the clergy and the church.
3. Reimbursements or advances must be paid out budgeted church funds. Budgeted amounts not spent must not be paid as a salary bonus or other personal compensation in any fiscal year.
4. The church may pay amounts in advance of the clergy's actual expenditure on either an "as needed" basis or by standard monthly expense "allowance." However, an adequate accounting of the advances by expense report must be made in the month following an expenditure. Any excess advance must be returned to the church within 30 days of the issuance of the advance.
5. It is understood by the various parties that all elements of this resolution must be carefully followed to prevent the church salary-paying unit from being required by regulation to list total payment of the following items on IRS information reports (W-2/1099-MISC) as "includable compensation." The primary responsibility of expense reporting is the clergy to the church payroll person.
6. By previous or concurrent resolution, duly adopted by the Church Council of the **AYNOR UMC** at a meeting held on **09/12/2011**, the following ordinary and necessary expenses as suggested for the employment needs of the clergy, are included in this accountable reimbursement policy for calendar year 2012.

*Church Council action is required for an increase to the total during the year, but such an increase cannot be funded by taking money from the minister's cash compensation. Circumstances dictate that the above expenses will vary from church to church and from time to time. Nonetheless, expenses assumed by the clergy in excess of the total are not excludable from reported compensation. They may or may not be deductible from taxable income on the clergy's tax return.
