January 8, 2023 Council Meeting

Phyllis Morrison opened the meeting with a request for approval of the minutes from the October 9, 2022 Council meeting. Carlisle Dawsey made the motion to approve the minutes as presented. Sara Whitner seconded the motion. The Council then voted to approve the minutes from the October 9, 2022 meeting.

Phyllis then asked for a report from the Finance Committee. Brad Dusenbury said that there was about \$220,000.00 cash on hand between the Budget Account, Special Account and Trustee Account.

Phyllis asked if any of the committee chairpersons had a report to give.

David Parker said that the Methodist Men would be meeting at 7:00 Thursday, January 12, 2023.

Don Hopson said that 44 shoe boxes and 15 Angel tree gifts had been given by the church in 2022.

David Parker then made the motion that January 8, 2023 be named as the first day of the church's discernment period. Sylvia Page seconded the motion. The Council then voted to approve the motion that January 8, 2023 was the first day of the 30 day discernment process.

David Parker then said that he had received three quotes for appraising the church property. David made the motion that the church accept the bid from Ronnie Cribb of Marion, SC to appraise the church property for \$1,250.00. Don Hopson seconded the motion. The Council then voted to approve the bid of Ronnie Cribb to appraise the church property.

David Parker then made the motion to hire the National Council for Life and Liberty to provide legal services. There would be a retainer fee of \$1000.00 with a \$3500.00 cap for legal representation for one year. Legal services would include a review of by-laws, a review of legal contracts, incorporations, and tax issues. The retainer would not cover the cost of litigation, court costs and filing fees. The motion was seconded by Linda Gerrald. The Council voted to approve the motion to hire the National Council of Life and Liberty.

David Parker then said that the church would have to carry liability insurance for three years that would hold The United Methodist Church harmless from lawsuits. David made the motion that the Council would authorize the Trustees to approve a liability insurance policy. Jeanne Doyle seconded the motion. The Council then voted to authorize the Trustees to approve a liability insurance policy.

David Parker then made the motion to have fund raisers to help pay down any loan debt owed by the church. Jeanne Doyle seconded the motion. The Council then voted to have fund raisers.

David then mentioned that the church would have to establish a new non-profit entity.

Phyllis Morrison asked Pastor Kelly about unpaid salary and benefits. Pastor Kelly said we had to pay the pastor's salary.

David Parker asked the Council to choose two Trustees to represent the church and to sign the separation paperwork on behalf the church. Bucky Jordan made the motion to have Allison Best and Mark Dawsey represent the church.

Katy Hucks seconded the motion. The Council then voted to have Allison Best and Mark Dawsey represent the church as Trustees.

New Business: There was a brief discussion about the need for a new copier for the church. Bill Altman made the motion to lease a new copier from Integrity Business Solutions of Conway, SC. Janett Elliott seconded the motion. The Council then voted to lease a new copier from Integrity Business Solutions.

Phyllis Morrison opened the meeting with a request for suggestions for any amendments to the proposed Bylaws for Aynor Methodist Church.

The following suggestions for changes to the Bylaws were made:

In Article 4.01. The statement that “Persons ceasing to be members of the local Church congregation shall cease to be voting members of the Church” would be changed to “Persons ceasing to be active members of the local Church congregation shall cease to be voting members of the Church”.

In Article 5.05. The wording of the bullet point “Administering the sacraments, and” would be changed to, “Administering the sacraments”.

In Article 6.01. The wording “The Church Council or its successor shall have general oversight of the administration and program” would be changed to “The Church Council shall have general oversight of the administration and programs”.

In Article 7.01. The wording would be changed to “The Charge Conference shall elect at least the following leaders: Chairperson of the Church Council, The Committee on Staff-Parish relations and its Chairperson, The Chairperson and additional members of the Committee on Finance, The Trustees, A Recording Secretary, The Financial Secretary, The Nominating Committee, and The Church Treasurer(s), if not paid employees of the Church.

The wording “Leaders shall hold office for a term of two years” shall be changed to “Leaders shall hold office for a term of three years”.

In Article 9.05. The wording “Any member in good standing may attend Church Council meetings of Aynor Methodist Church. They will be given voice but will not be able to vote.” This wording will be changed to “ Any member in good standing may request to speak before the Church Council meetings of Aynor Methodist Church. He or she must obtain permission from the Church Council Chair and Pastor in order to be included on the meeting agenda. He or she will be given voice but will not be eligible to vote. Only members of the Church Council are eligible to vote during Church Council meetings.

Sylvia Page made a motion to accept the changes in wording in Article 9.05. Catherine Johnson seconded the motion. The Council then voted to accept the proposed changes in wording to the Bylaws in Article 9.05.

Pamela Hucks made a motion to approve the Bylaws as amended. Sara Whitner seconded the motion. The Council then voted to approve the Bylaws as amended.

The meeting was then adjourned.

April 30, 2023 Council Meeting

Pastor Kelly opened with a prayer.

Phyllis Morrison then asked the Council members to review the minutes from the March 19, 2023 and April 16, 2023 Administrative Council meetings. Brenda Alvarez made the motion to approve the minutes as presented. Patricia Whitner seconded the motion. The Council then voted to accept the minutes as presented.

Phyllis Morrison then asked for Committee Reports. Brad Dusenbury reviewed the 2023 General Budget, and recommended that the money raised at the Spring Festival be moved from the Special Account to the Budget Account. Rachel Dawsey said she would move it.

Sara Whitner announced that the Epworth offering would be received on Mother's Day.

Beth Davis spoke about the next meeting of Forever Young.

Bucky Jordan said that there were 13 young people in the Confirmation class.

Phyllis asked if there was any old business to discuss concerning the Spring Festival. David Parker thanked everyone for their support and help in raising \$17,763.00 at the Spring Festival.

Phyllis then asked for reports and discussion on New Business.

'(1) Funds due to the Conference - Pastor Kelly said that \$122,479.00 would be needed to be put in Escrow by May 31, 2023. The separation from UMC would be at 12:00 AM on July 1, 2023.

'(2) Establishment of new bank accounts - Phyllis Morrison said that new bank accounts will have to be established for Aynor Methodist Church. Pastor Kelly said that the Federal ID number has been established for the new church.

'(3) Number of signatures needed for the new accounts - There was a discussion concerning the number of signatures that will be needed for the new bank accounts. Sylvia Page made the motion that the signatures of Pamela Hucks, and Jeffery Singleton be added to Rachel Dawsey and Brad Dusenbury on the new bank accounts. Bucky Jordan seconded the motion. The Council then voted to put the signatures of Pamela Hucks, Jeffery Singleton, Rachel Dawsey and Brad Dusenbury on the new bank accounts.

'(4) Delete the word "United" from the church sign, bus, etc. - There was a discussion about removing the word "United" from any church sign and bus decal. Pastor Kelly asked Mark Dawsey if the Trustees would take care of making any necessary changes to the church sign and church bus decals. Mark Dawsey said the Trustees would take care of it. Mark Dawsey also pointed out that a change would be needed to the church information sign that had been put up by the Town of Aynor. Mark said that he would talk to Tony Godsey about the town's church information sign.

'(5) Need new Facebook Page - There was a discussion about the church's Face-Book page. Pastor Kelly said that we need to establish a new Face-Book site and that the church needed to advertise so that people could find the new Face-Book site.

April 30, 2023 Council Meeting

'(6) Way Forward Committee – Membership transfer - There was a discussion concerning membership transfer. Pastor Kelly said that every church member would have to fill out a form, stating whether they wanted their membership to stay with United Methodist Church conference, move to the Aynor Methodist Church, or to be moved to a different church. It would be announced from the pulpit and by e-mail that each member would be given two weeks to fill out their form and return it to the church. The forms will be distributed on May 7, 2023. The completed forms must be back in by May 21, 2023. The names of any member who do not fill out the membership transfer form will be sent in to the United Methodist conference as a person not wanting their membership transferred. Don Hopson made the motion that this membership transfer process be used. Sara Whitner seconded the motion. The Church Council then voted to use the above stated membership transfer process.

Don Hopkins then opened a discussion on creating central control center for monitoring security in around the church. David Parker said that the safety committee had been discussing this.

David Parker said that the title search work was on-going and would be completed by May 15, 2023 and sent on to the Conference. The title search may cost a little more than what was originally expected.

Sylvia Page asked how many churches in South Carolina with leaving the United Methodist Church. Pastor Kelly said that information had not been released yet.

Pastor Kelly then closed the meeting with a prayer.
