Beth Westbury is the treasurer of the South Carolina Conference and she will determine the costs from the infortion submitted to her.

The ballots were distributed to the members present. The result of the vote is, 17 members voted to leave the UMC.

Two trustees were voted on as the ones to represent Bethel in the continuing process. They are Tracy Pope and Tim Flynn.
