RECORD OF PREPARATORY MEMBERSHIP

(Required)

The Discipline states (Par. 232.2) that the preparatory membership roll shall contain the names of baptized children and youth of the church 18 years and under, who are not full members, and other persons who have been enrolled in confirmation preparation.

Names should be entered chronologically. The Discipline requires that these names be reported to the Charge Conference annually.

The date received and the name of the minister provide necessary data.

The way persons are removed as preparatory members may be recorded FM (full membership), CT (certificate of transfer to other churches), CR (constituency roll), D (death), or W (withdrawal).

CHRONOLOGICAL ROLL OF FULL MEMBERSHIP

(Required)

This is the permanent record required by *The Book of Discipline* in The United Methodist Church. Copies should be made of it and kept in a safe place in case of fire or destruction. Since pages can be removed from the post binder, copies can easily be made.

This membership roll should be kept up-to-date and in chronological order. Additional volumes can be added when membership expands. Post extensions are available.

Pertinent information such as birth date and name of spouse (if applicable) should be entered. Use of this column makes it unnecessary to change the original name entry when a member marries. Under the "Received" column, if applicable, indicate date and how, e.g., CF (confession of faith); R (restored); CT (transferred from other United Methodist churches); or OD (other denominations).

The last two columns for removals help audit each chronological page and provide necessary data for Charge and Annual Conference reports in an easily verifiable way. Under the last column, "How," type of action taken may be CT (certificate of transfer), D (death), W (withdrawal), or CC (Charge Conference action).

How do you replace or establish a Chronological Roll where records have been destroyed, lost, or mismanaged? The following suggestions are offered:

1. If a Family Roll exists, it should include date of reception into membership. Make a list by year as far back as records allow. Assign numbers alphabetically by year if dates are not specific. For example, a church which was organized and received 40 members in 1927 could assign the numbers 01-40 to the alphabetical list of persons received that year. If 28 more members were received in 1928, the numbers 41-68 would be assigned to the alphabetical list of those persons. Continue listing until present. Charter members' names should be available; these persons would be assigned the first numbers on an alphabetical basis.
2. If you have an annual list of dates and members received for Charge Conference, you can establish an approximate chronological order from these.
3. Check church directories for names.
4. Card files may include the date of reception.
5. If none of these is available, a committee representing all age groups will need to assemble names and personally check with families and individuals who may still be living.
6. If a church has maintained good records, excepting a Chronological Roll, it could begin with 1980 and start with 1001 or 2001 to build for the future.

CONSTITUENCY ROLL

(Required)

A constituency roll includes the names and addresses of persons who are not members of the church, including unbaptized children, dedicated children, church school members, preparatory members who have reached the age of 19 who have not been received into full membership, and other nonmembers for whom the local church has pastoral responsibility (Par. 232.4).

This record is required by *The Book of Discipline* for each church (Par. 232). The responsibility rests with the pastor to report its status to the Annual Conference (Par. 234.2).

The membership secretary is directed to provide this and other lists to the Administrative Board regularly. Also, as a member of the Evangelism Work Area, the membership secretary can provide data for membership recruitment (Par. 235).

The use of the baptismal reference number serves as a cross-reference to provide personal data in order to avoid duplication.

The current list of addresses provides a working list for church growth and ministry. The flexibility added by the ability to remove these pages helps with record-keeping. A column is provided for indicating which persons are prospective church members.

The "Removed" column includes both how and the date. Removal may be by FM (full membership), D (death), or W (withdrawal).

It would be helpful to list the membership of the deceased: Was he or she a preparatory member, constituent member, affiliate or associate member? This record will provide a complete list of all funerals provided by the ministry of the church.

The provision for indicating members will assist in identifying which deaths were those of members and which were nonmembers.

"Disposition of the Body" covers the option of burial, cremation, or other means.

The name of the minister who officiated at the service should be included to show continuity of pastoral care within the church.

RECORD OF PREPARATORY MEMBERSHIP

(Required)

The Discipline states (Par. 232.2) that the preparatory membership roll shall contain the names of baptized children and youth of the church 18 years and under, who are not full members, and other persons who have been enrolled in confirmation preparation.

Names should be entered chronologically. The Discipline requires that these names be reported to the Charge Conference annually.

The date received and the name of the minister provide necessary data.

The way persons are removed as preparatory members may be recorded FM (full membership), CT (certificate of transfer to other churches), CR (constituency roll), D (death), or W (withdrawal).

CHRONOLOGICAL ROLL OF FULL MEMBERSHIP

(Required)

This is the permanent record required by *The Book of Discipline* in The United Methodist Church. Copies should be made of it and kept in a safe place in case of fire or destruction. Since pages can be removed from the post binder, copies can easily be made.

This membership roll should be kept up-to-date and in chronological order. Additional volumes can be added when membership expands. Post extensions are available.

Pertinent information such as birth date and name of spouse (if applicable) should be entered. Use of this column makes it unnecessary to change the original name entry when a member marries. Under the "Received" column, if applicable, indicate date and how, e.g., CF (confession of faith); R (restored); CT (transferred from other United Methodist churches); or OD (other denominations).

The last two columns for removals help audit each chronological page and provide necessary data for Charge and Annual Conference reports in an easily verifiable way. Under the last column, "How," type of action taken may be CT (certificate of transfer), D (death), W (withdrawal), or CC (Charge Conference action).

How do you replace or establish a Chronological Roll where records have been destroyed, lost, or mismanaged? The following suggestions are offered:

1. If a Family Roll exists, it should include date of reception into membership. Make a list by year as far back as records allow. Assign numbers alphabetically by year if dates are not specific. For example, a church which was organized and received 40 members in 1927 could assign the numbers 01-40 to the alphabetical list of persons received that year. If 28 more members were received in 1928, the numbers 41-68 would be assigned to the alphabetical list of those persons. Continue listing until present. Charter members' names should be available; these persons would be assigned the first numbers on an alphabetical basis.
2. If you have an annual list of dates and members received for Charge Conference, you can establish an approximate chronological order from these.
3. Check church directories for names.
4. Card files may include the date of reception.
5. If none of these is available, a committee representing all age groups will need to assemble names and personally check with families and individuals who may still be living.
6. If a church has maintained good records, excepting a Chronological Roll, it could begin with 1980 and start with 1001 or 2001 to build for the future.

CONSTITUENCY ROLL

(Required)

A constituency roll includes the names and addresses of persons who are not members of the church, including unbaptized children, dedicated children, church school members, preparatory members who have reached the age of 19 who have not been received into full membership, and other nonmembers for whom the local church has pastoral responsibility (Par. 232.4).

This record is required by *The Book of Discipline* for each church (Par. 232). The responsibility rests with the pastor to report its status to the Annual Conference (Par. 234.2).

The membership secretary is directed to provide this and other lists to the Administrative Board regularly. Also, as a member of the Evangelism Work Area, the membership secretary can provide data for membership recruitment (Par. 235).

The use of the baptismal reference number serves as a cross-reference to provide personal data in order to avoid duplication.

The current list of addresses provides a working list for church growth and ministry. The flexibility added by the ability to remove these pages helps with record-keeping. A column is provided for indicating which persons are prospective church members.

The "Removed" column includes both how and the date. Removal may be by FM (full membership), D (death), or W (withdrawal).
