**Chronological Reference Number.** Names of members should be entered chronologically. Enter the chronological reference number in this column opposite the name. (Should an alphabetical list of full members be desired as a cross reference to this section, *Individual Membership Roll Card, No. 855*, should be used.)

**Baptismal Reference Number.** If the person was baptized previously and his name entered in the *Record of Baptisms and/or Record of Preparatory*

*Membership sections*, enter the same baptismal reference number in this column.

**Marital Status.** Single, married, or widowed.

**To Whom Married.** When a woman whose name is already on the roll marries insert the family name of the man in this column. Example: Mary Elizabeth Jones marries a Mr. Johnson; write "Johnson" opposite her name in this column. This obviates the necessity of recording her record in a new place.

Received into Full Membership. In the "How" column enter the proper symbol: CF—Confession of Faith, PM—Preparatory Membership, OD—Other Denomination, R—Restored, CT—Certificate of Transfer (in this case enter the name and address of the church in the column "Transferred From").

Membership Terminated. In the "How" column enter the proper symbol: OD—Other Denomination, D—Death, EXP—Expulsion, W—Withdrawal, RCC—Removed Charge Conference Action, CT—Certificate of Transfer (in this case enter the name and address of the church in the column "Transferred To").
