



W. Cecil Garrett Elected secretary by Conference 4/12/59

There was a special quarterly conference called by Rev M. B. Lee on April 12, 1959 at Dials Methodist Cherch, Route 2, Gray Court, S. C. for the Dials and Shiloh Churches, and authorized by District Supt. E. P. McWhirter. This conference called for the purpose of discussing the financing of the Dials-Shiloh Parsonage.

Mention was made by the pastor that the total cost of the well came to \$205.26. Also mention was made of a pre-arranged agreement between the parsonage building committee's of the two churches that both churches use the study in Disla church in lieu of Dials Church using the water from the Charge parsonage. The churches willlfurnish the fixtures for the study and office on the regular basis of 60-40. Mention was also made that the old Gray Court parsonage has been appraised at a figure of \$9080.00. The Dials Church will receive \$3087.20 and the Shiloh Church will receive \$1182.40 from the proceeds of the Gray Court Charge Parsonage. Each church will receive 500.00 from the Conference to be applied on the building of a new Dials-Shiloh parsonage.

It was announced by Rev Lee that the bid of 13,023.30 had be accepted by the parsonage building committees of the Dials and Shiloh Churches. These committees recommended that an additional \$3000.00 be provided for paying for the well, pump, and furnishings for the parsonage and study. The above mentioned contract for the building of a new parsonage has been awarded to David Snipes, Building Contractor, Laurens, South Carolina.

After much discussion by the members of the conference, a motion was made by Marion Wilson that these two churches borrow the full amount of \$16,823.30 and pay back on the 60-40 basis, ie Dials Church paying 60% and Shiloh Church paying 40%, that we collect from the Gray Court and Trinity Churches the amount due us from them and the amount applied on the note upon receipt be on a 60-40 basis, also that the \$1000.00 to be received from Church Conference on the note upon receipt. This motion was seconed and voted upon-16 for (unanimous). The members of the Quarterly Conference were:
