RECORD OF BAPTISMS  
(Recommended)

This record is to report all baptisms administered in the parish.

Each person should be entered chronologically. The baptized person should be posted on the Permanent Church Register, and the chronological number from the register should then be posted on the Record of Baptisms.

The date of baptism and name of the officiating pastor should be entered in the proper column. Place of birth should include city, county (borough, etc.), state or appropriate geographical or civil divisions for countries outside the United States. List these and the name of the church for the place of baptism.

When the baptized child lives in a community not served by the pastor who administers the Sacrament of Baptism, the pastor is responsible for reporting the baptism to a pastor who serves in the area where the baptized child lives in order that the child may be transferred and the child's name may be entered on the Permanent Church Register of a church in that community (¶233).

When listing parents' names, the inclusion of the mother's maiden name is helpful for historical and familial purposes.

(Required)

This is the permanent record required by *The Book of Discipline of The United Methodist Church*. Copies should be made of it and kept in a safe place in case of fire or destruction. Since pages can be removed from the post binder, copies can be made.

This membership record should be kept up-to-date and in chronological order. Additional volumes can be added when membership expands. Post extensions are available.

Enter all pertinent information such as full name and date of birth. Under "Received as a Baptized Member," please mark the date of baptism if the member was baptized in the local church or the date the person was received by transfer if applicable. All members on your register should have a date in this column. Under "How" please mark (B) Baptized, T (transfer from another United Methodist church), or OD (from other denominations).

Under the "Received as Professing Member" column, if applicable, indicate date and how, e.g., PF (profession of Christian faith), R (Restored), T (transfer from another United Methodist church), or OD (from other denominations).

To facilitate the gathering of racial/ethnic data on church members, record in the "Racial/Ethnic" column the appropriate letter from the key on the bottom of the form. To facilitate gathering gender data, record the appropriate letter (F or M) from the key on the bottom of the form in the "Gender" column.

The last four columns for removals help audit each chronological page and provide necessary data for charge and annual conference reports in an easily verifiable way. Under the column "How" the type of action taken may be T (transfer to another UMC), OD (to other denomination), D (death), WD (withdrawal), WC (withdrawal under charges) or CC (charge conference action). In the columns headed "B" (Baptized Member) and "P" (Professing Member), please put a check mark if the person's membership is removed from that category. NOTE THAT BAPTIZED MEMBERS CAN BE REMOVED FROM THE CHURCH REGISTER ONLY THROUGH TRANSFER TO ANOTHER UMC, TRANSFER TO OTHER DENOMINATIONS, OR DEATH. (For instance, if a professing member transfers to another UMC, there would be a check mark in both categories as that member will no longer be a member of this fellowship. If, however, a professing member is removed by charge conference action, there would be a check mark only under professing member, indicating that this person remains on the church register as a baptized member.)

**ADDING BAPTIZED MEMBERS TO YOUR PERMANENT CHURCH REGISTER:** Starting in 2005, Baptized persons are to be added to the Permanent Church Register as they are now, according to the *Discipline*, members of the local church. It is recommended that churches begin by adding the baptized persons who were on the previously existing Preparatory Roll as of December 31, 2004. (Note that after January 1, 2005, the Preparatory Roll no longer exists.) It is not necessary to go back historically to add persons to the Register, but do note that all professing members on the Register to date are also baptized members and need to be treated accordingly in regard to membership removals when performing the audits. Beginning with January 1, 2005, all newly received baptized members are to be recorded on this Permanent Church Register.
