Finance Committee:

Explanation of the budget:

Bill reported David Cling cut the pine trees at the parsonage for half price \$1600.00. The proposed budget for the new year 2022 was discussed. We took in more than we used under spending. There will be a pay increase of 2% for all church employees, the water bill is trending upward since we are in the sanctuary more, the grass is being watered more, which made those two items \$100.00. The apportionments were down totaling \$700.00; this was an average of 3-5 years, tailored to the individual church and what it can afford. Insurance went up, this could be \$200.00 or more. The church needs to purchase Workman's Compensation at a cost of \$500.00 to \$600.00; this amount is not in this budget. We will need to go out and get quotes. This is not a final budget for direct pay. Greg made a motion to accept the budget, Emily 2nd, all approved.

Pastor Matt:

Pastor Matt has signed and sent to conference his continuing education, other churches he has served, and the transition from one charge to another. All other is seminary completed.

Annual Report of Trustees: Information gathered by Greg. Insurance; parsonage and church, deed with book and page number at the Aiken County Courthouse. All in order, Greg signed as trustee. This is public information, and is covered by insurance.

Report from Nominations Committee: One position still to be filled, given to Charge Conference for a vote.

Ministerial Support Report: Pastor's salary will stay the same as it was in 2021. \$52,420.00 for the charge. Bethel UMC -\$31,452.00, Wesley Chapel UMC -\$20,968.00. This includes compensation in the package to be given at Charge Conference. This amount is in the budget that was reviewed.

Charge Conference Goals: How is the new ministry going?

Questions:

1) Has your church vision shifted since COVID 19?

The church made a transition to an online service, reaching more people, surpassing the original "40 by 20" goal.

2) What new tools have you learned about and used?

Cameras, drive up services, blessing bags, T.V.'s, volunteer to play organ, Bible study.

3) Describe your churches strengths, and your churches growing edges during this pandemic?

Adapt and be flexible with online service, and T.V.'s. Everyone adapted to the blue tape and financially, people have been very supportive with their tithes.

4) Describe the impact the Pandemic has had on any new or existing ministries started.

The UMW had no in-person Merry Christmas Dinner, no Easter Sunrise Service, no Fifth Sunday Sing, the UMM had no Men's Prayer Breakfast. The Children's Ministry dropped off, and Sunday School was canceled. No caroling at the nursing home, and no cantata. The playground, however, was installed in 2020, and we started a drive-up prayer service, as well as an online ministry.

5) What ministries have you decided to keep and what are you going to do away with or let go?

The food collected each month will now go to the Blessing Box instead of the Senior Center; we do however, contribute \$500.00 to ACTS.

6) We are tracking with our apportionments.

Report of the Pastor:

We had three deaths between our two charges for 2021: Kenneth Ellis, Sarah Sullivan, Carl Overcash, Sr.

The State of the Charge will be given at Charge Conference.

Jan Burriss of Wesley Chapel UMC will be the chairwoman of the PPRC for 2022.

Account Reimbursement Policy: Set aside for pastor visits to hospitals or homes.

Parsonage Report:
