MOUNT LEBANON UNITED METHODIST CHURCH STATE OF THE CHURCH REPORT 2004

Mount Lebanon UMC has suffered several losses this year due to deaths among our membership. Unfortunately, this will continue to present a challenge to us as we strive to be the Church located between Ninety Six and Greenwood. This congregation is aging, with the majority of members over age 75. We have seen several members face declining health over the past year that prevents them from attending any services or activities at the church. The list of shut-ins continues to grow, creating an ever-increasing need for visitation and ministry to this growing population. We continue to offer the Home Touch ministry to them, providing them with devotional material and bulletins to make them feel more connected to the congregation. Because of the faithfulness of our volunteer in the sound room, we are able to make a cassette tape of each service available to our shut-ins.

There continues to be a need for visitation and invitation to unchurched people around Mount Lebanon. Most of the people who have moved into the immediate area are different from the long-standing members of this congregation in terms of ethnicity, financial status, and family makeup. The homes in the area tend to be older, and are more affordable to young, single-parent families and persons who are just barely getting by. There are also numerous mobile homes within 2 miles of the church. This presents a challenge to us as a congregation - how to reach out and invite persons to our church who have different backgrounds, different values, and different challenges. In order to be effective, a program of visitation must be carried out by the laity - by those who can sit in the pews with the people they invite to attend our services. Hopefully, this congregation will make this a priority in the coming year.

The members continue to be faithful in their stewardship. Giving has remained constant, even as our people have gotten older. This congregation has participated in numerous mission endeavors throughout the year. When asked to respond, the members of Mount Lebanon always come through.

A new memory garden area was completed on the lower side of the entrance to the Sanctuary, making the building more inviting to all who enter the parking area. The congregation is willing to make adjustments to the seating inside the sanctuary in order to accommodate persons with physical handicaps that make it difficult for them to sit in the regular pews.

There continues to be an air of enthusiasm about being the Church, a sense of hope for now and for the future. Even so, Sunday School attendance has lagged this year, due in part to the aging of the congregation. We continue to be blessed by an excellent choir director and a wonderful organist. The combined choirs, under the direction of the Mount Lebanon choir director, presented a Christmas cantata at both churches as well as, the Greenwood Seventh Day Adventist Church. The choir also got together to sing for the

Moravian Love Feast and for a Sunday evening service at the Epworth Camp meeting this summer.

The community health education offerings sponsored by our Congregational Nurse were well attended by members of both churches. The first Annual Chargewide Picnic was well attended, and will be scheduled again next year.

Attendance at both Christmas Eve services was light, prompting me to consider offering only one service this year. Ash Wednesday attendance was extremely poor, although those present participated actively in the service. Holy Week services were divided between the two churches, and were well-attended by folks from both churches.

The United Methodist Women and United Methodist Men continue to be active for most of the year, participating in a variety of mission projects. The majority of the congregation provided items for the Samaritan's Purse Christmas shoeboxes, which were assembled by the UMW. Sunday School classes also participate regularly in mission projects.

As I see it, the greatest needs at Mount Lebanon UMC are as follows:

- 1. Coordinated lay visitation to the people in the surrounding housing developments and trailer parks.
- 2. Consistent programming for the children and youth that attend with a goal of increasing numbers as programs and activities are made available.
- 3. Outreach and transportation aimed at retirees and persons in assisted living facilities in the area.
- 4. Continued ministry toward the shut-in members of the congregation.
- 5. More intentional ministry and fellowship opportunities for senior adults.

State of the Mount Lebanon Church 2005

In many ways, this has been an encouraging year for Mount Lebanon. There has been more effort made on the part of a few of our members to invite friends and neighbors to Worship and fellowship activities. Several of these visitors have become regulars, and will hopefully decide to join our membership at Mount Lebanon. We have had increased attendance in the Sunshine Club and, until recently, UMY meetings. Our nursery department has been in use more frequently this year than in the past several years. We have just begun a community-wide 40 Days of Purpose study led by two women of our congregation. The gifts of our people in the areas of music continue to be a source of inspiration that deepen the spirit of worship in our services. There is increased participation in fellowship and other activities and an overall spirit of enthusiasm for Worship. The members are loving and caring and encouraging to one another and to their pastor.

Even with all of these positive aspects of community at work in the Mount Lebanon Church, there has been an overall decrease in attendance at Sunday School and Worship. This is due almost entirely to the aging of some of our most faithful members. The majority of members are well past retirement age, and many suffer from serious medical and physical problems that make it nearly impossible to get out and come to Worship or any other activities. There is an ever-urgent need to bring in new members if this congregation is to remain viable.

Even so, there remains some resistence to welcome people who are different from the majority of our members. This seems to be an unconscious, or maybe sub-conscious feeling among our older members, but it is nevertheless impacting the potential for growth. There has been some improvement this year, as the good folks here realized the nature of our decline in attendance and have made an intentional effort to get to know visitors when they attend. Now, visitors comment on the friendly welcome that they receive from the members, which has great promise for bringing them back, again.

One of the greatest hopes for growth is the possible Mothers' Morning Out program that is being investigated for the next School Year. This program will provide a ready access to the community at large with which to make contact, as well as infusing these buildings and members with the kind of enthusiasm and life that comes with the presence and laughter of children. This idea has been embraced by most of the membership, which is highly encouraging.

There is a missional spirit among the members that is evidences by the way in which they respond to personal needs such as ET House, Tsunami and Hurricane relief, the Appalachia Coat project and Operation Christmas Child. The people of Mount Lebanon are generally ready to offer some kind of assistance when community needs are identified. They provided filled bookbags for a needy school, food for the local Food Bank, meals for several of our shut-ins, Christmas gifts for several needy families, etc.

There is, however, a deeply entrenched reluctance to fund 100% of apportionments. This reluctance is justified, in the minds of the congregation, by the lack of weekly giving and the need to "take care of our own needs." There has been a steady increase in apportionment funding over the past several years, but this is not enough. There has also been great resistance to the idea of making regular, monthly payments on apportionments throughout the year. Part of this is due to the lack of consistency in weekly giving that makes it difficult to pay the salaries and utilities when due at times throughout the year. Still, this is a mindset that needs to change for real stewardship and growth to be possible.

We met only 2 of our 5 goals for 2005 (see last year's State of the Church Report). From a pastoral standpoint, we need the following for 2006:

- coordinated lay visitation to the people in the surrounding housing developments and trailer parks
- 2. consistent programming for children and youth
- 3. outreach and transportation aimed at retirees
