Full Name. The full name of each individual who receives baptism should be recorded by family name and Christian name.

Enrolled as Preparatory Member? If the baptized person is enrolled as a preparatory member, write "Yes" in this column. If not, write "No."

Date of Birth and Place of Birth. The date of birth should be entered as "Nov. 25, 1915" or "Nov. 25, '15." The city or county and state should be given as the place of birth and not the name of the hospital.

Baptized. Date of baptism and name of officiating minister should be entered in proper columns. The city or county and state in which the person was baptized should be entered in the column "Place" instead of the name of the church.

Names of Parents. The Discipline of The Methodist Church requires that the names of the parents

of baptized children be recorded. Space is provided for this information. The parents' names should be entered as John E. and Elizabeth Talbot (mother's maiden name) Moore.
