PASTOR'S REPORT Antioch/New El Bethel Charge 2020

Following the Antioch/New El Bethel Charge Conference on September 16, 2019, Darrell Ricketts and I were continuing to enjoy our ministry with the wonderful people of the Antioch and New El Bethel congregations. We finished 2019 having done the following:

- 1. Monthly youth gatherings at Antioch;
- 2. Homecoming at both churches;
- 3. Men's and women's breakfast meetings at New El Bethel;
- 4. Fellowship Gathering and Supper at Antioch;
- 5. Winter clothes "give-away" and soup lunch at NEB;
- 6. All Saints observance;
- 7. Chicken bog fund-raiser at NEB;
- 8. Antioch Revival;
- 9. Charge Advent Bible Study;
- 10. Christmas Fellowship Meals at both churches;
- 11. Christmas Eve Communion Services, Darrell leading the one at NEB and me at Antioch.

Of course, Darrell and I continued to alternate Sundays preaching at Antioch and New El Bethel, and I cannot overemphasize how thankful I am for Darrell's partnership in ministry at the charge. He is certainly a dear friend as well as my Associate Pastor!

Darrell and I met at the end of 2019 to plan our ministry for the first several months of 2020, not knowing that there would be an "interruption" in a few short months, an "interruption" that would change the course of our ministry for the year. We were excited about what God was planning for Antioch and New El Bethel in the New Year. For two and a half months, we worshipped "as usual" and again met with the Antioch youth, had fellowship meals, enjoyed breakfasts with the NEB men, started a Sunday morning Prayer Time at Antioch, and began a charge Lenten Bible Study.

THEN the "interruption" called a COVID-19 Pandemic began! Like most other churches, we immediately discontinued "in-person" worship services and were unsure what we would do to stay connected with the Antioch and New El Bethel congregations. By the first of April, with the huge help of my much-more-technologically-savvy Associate Pastor, we began Zoom messages and had a fairly good number of folks tuning in. We continued the Zoom messages and also started Facebook Live messages until we began "in-person" services at both churches on June 14. We tried a couple

Parking Lot Services at Antioch before June 14, which were well-received and wellattended.

Needless to say, folks at both Antioch and New El Bethel were happy when the "in-person" services resumed. Of course, some of our members have been reluctant to return to church, yet, but a number of them are watching the Facebook Live services that have continued. Also, like many churches that are having online services during the pandemic, we're reaching MANY people with the Good News about Jesus – more than we would ordinarily reach at the two Sunday morning worship services. With that in mind, we're planning to keep on having Facebook Live services even when the pandemic is over. One thing I've tried to do from time to time is to make telephone calls to church members to check up on them or to see how they're doing following surgical procedures; hopefully, they'll feel a little more "connected" when their pastor calls.

Attendance at both churches is down, but Darrell and I certainly understand why most of our older members and others with underlying health issues are not attending church. They'll be back, I'm sure! Darrell and I are very thankful that the financial situation at Antioch and New El Bethel is stable. The members of both churches continue to give (or send) their tithes and offerings so ministry can move forward. It really WILL be SO good – and FEEL so good – when we can ALL return safely to worship God together! We believe that all this "shall pass," and we'll be able to adjust to the "new normal," whatever that may look like in the future

With a few months remaining in 2020, we hope to begin having Holy Communion again soon (which we and many others have been missing), insuring everyone's safety when they receive the elements of bread and "wine"! The Men's and Women's Fellowship groups at New El Bethel will be working on the resumption of their meetings and times together over the next month or so. I'm considering doing a Zoom Advent Bible Study, too. I'm sure that Antioch and New El Bethel will be involved in some outreach ministries during the Thanksgiving, Advent, and Christmas seasons, which will be good for both congregations. We certainly don't want ministry and mission opportunities to stop during these very different, difficult, and challenging times. I know that God's grace and love will sustain us as together we seek His will and His way for Antioch and New El Bethel United Methodist Churches! Darrell and I LOVE serving the awesome people of these two churches!

Associate Pastor's Report Antioch/New El Bethel Charge October 1, 2020

As I think back to last year's Charge Conference it seems the world has turned upside down. The world pandemic has caused us to look beyond the traditional ways our churches were striving to meet our mission of "making disciples for Jesus Christ" to areas we had never considered before.

I am sure the Senior Pastor will address many of the activities that have taken place since last year's charge conference, but I want to highlight some that were special to me. At Antioch UMC, we continued to have activities for the youth of our church which was very rewarding. Last December we had our second Candlelight Remembrance Service at the cemetery which was well attended by the community. At New El Bethel UMC our men and women's groups continued to meet and plan service projects for the community. We also had a wonderful Christmas Fellowship Lunch that was attended by all. Experience over the past few years has shown us that joint events for the churches are not always well attended by the other congregation depending on where it is held, so we took special occasions such as Christmas Eve to provide simultaneous services at both sites. We have committed ourselves to meeting the needs of each congregation to help them grow individually to meet the needs of their individual communities.

In March, we were all caught off guard when services were suspended due to Covid-19. Everyone was unsure what the future would hold, and we were unsure how to meet the needs of our members. Within a few weeks, we learned how to conduct Zoom meetings and Rev. Knight hosted our first Zoom worship service. We learned together how to modify the order of worship to accommodate the new format, even when we did not fully understand the technology. We then saw the need to expand the format for those who were not able use Zoom. Since we already had Facebook pages for both churches, we decided that Dickie (who was not on Facebook) would have a Zoom service at 9:30 AM on Sundays and I would have a Facebook Live service at 10:30 AM. We saw a boost in participation with this format and continued it for several months. We also monitored what other churches were doing in the area. In May, we wanted to do something special for Mother's Day, so we planned our first "Parking Lot Service" at Antioch. We also broadcast it through Facebook Live. Everyone who attended seemed to appreciate getting back together, even if it was from a distance, and seeing their brothers and sisters in Christ. We invited the New El Bethel members to join us at Antioch for this service and recognized the mothers in attendance with flowers. This service was such a success, we held another for Pentecost Sunday which saw another crowd in attendance. Throughout the quarantine Dickie and I continued to provide bible study and Sunday worship through Zoom and Facebook Live. The views of the services on Facebook Live showed we were reaching several hundred each week through the "views" which let others know our little churches were alive and well.

During June, churches could re-open using safety guidelines and we decided that June 14th would be our first services back in the churches. Both congregations were excited, and groups got together to clean and prepare the sanctuaries. On June 14th we held our first services back in the churches, but because we knew not everyone was comfortable returned, we broadcast the services through Facebook Live. My wife attended as the "cameraman" on my Sundays and I went on Dickie's Sundays to operate the video for him. This format allowed us to provide worship experiences for those who were able to attend as well as those who were still homebound. This has opened our churches to the larger community and has led to others joining us. We have also seen tremendous financial support throughout the quarantine and pandemic. Both churches have remained financially sound and we appreciate the support everyone has given Dickie and I throughout these unprecedented times.

The lesson we have all learned throughout this challenging time is that the church is so much more than the building, it is the people. Our members have continued to provide financial support of ministries such as the Gideons and Epworth as well as commitment to pay 100% of our apportionments. We have also collected food donations for the local food bank as well as providing emotional support to our older members while they are isolated at home. God has been good and continues to bless me, Dickie, and these two special congregations and even in difficult times, their lights continue to shine for Jesus in a dark world.

Minutes of the Charge Conference

The Charge Conference for the ANTIOCH - NEW EL BETHEL CHARGE (276700) of the Marion District of the South Carolina Annual Conference was heldThe Charge Conference for the ANTIOCH - NEW EL BETHEL CHARGE (276700) of the Marion District of the South Carolina Annual Conference was held October 3, 2021 at New El Bethel United Methodist Church chaired by Rev. Tim Rogers. A devotional service was conducted by Rev. Tim Rogers.

In light of the pandemic, the Cabinet has revised the Charge Conference Minutes questions for 2021, to help churches reflect on the changing context for ministry. These questions are from the newly revised Forward Focus materials and are intended to help a church reflect on how the pandemic has impacted ministry. I. Pandemic Ministry

We are constantly changing and growing. We are not the same today as we were yesterday. This section should give you an idea about how your church has weathered the pandemic. It should give your church an idea about what you may need to do in order to move forward. Take time to pray and listen.

A. Has your church's vision shifted since COVID-19?

Antioch/Conway (276700): The vision of Antioch United Methodist Church has not "shifted" dramatically since COVID-19. Except for the three- or four-month "interruption" of in-person worship services in 2020, Antioch has continued to have Sunday services. The congregation certainly has the vision to be a "light" in the community and to grow numerically and spiritually, hoping to reach others with the love of Jesus in the years to come.

New El Bethel (277101): The vision of New El Bethel United Methodist Church has not changed drastically since COVID-19. The congregation continues to have the vision of being a "beacon" for Jesus Christ at a very busy intersection in Conway. New El Bethel, "the most loving place in town," desires to welcome those who don't know Christ, newcomers, and the unchurched and wants them to experience the fellowship of the church.

B. What new tools did you have to learn about and use?

Antioch/Conway (276700): The only "new tools" used at Antioch United Methodist Church during the pandemic was "Zoom" for services and a prayer time when in-person services were not held and the use of Facebook Live for some Parking Lot Services.

New El Bethel (277101): When in-person worship services were temporarily discontinued at New El Bethel United Methodist Church, Zoom and Facebook Live messages were delivered by Rev. Knight and Rev. Ricketts. Some Parking Lot Services were held at New El Bethel's "sister" church, Antioch UMC, and some New El Bethel members attended those services. When in-person services resumed at New El Bethel, the church began and has continued to "stream" the services via Facebook live so that members who have not yet returned to church, the sick and shut-in, and MANY others may experience worship and hear the Good News about Jesus every Sunday.

c. Describe your church's strengths and your church's growing edges revealed during the pandemic.

Antioch/Conway (276700): Antioch's major strength during the pandemic is being a consistent and faithful "light" for others in the community. People have certainly observed that

worship services have continued on Sunday mornings with very few interruptions. If there's a "growing edge," it would have to be the need to intentionally reach out to others who are not Christians and/or who are unchurched and to encourage them to consider becoming a part of the fellowship and membership of Antioch UMC.

New El Bethel (277101): Again, one of New El Bethel United Methodist Church's strengths is its strategic location at a very busy intersection in Conway, so the church's visibility/location is a strength. Also, there is a "faithful" group of individuals who make sure that newcomers, including non-Christians and the unchurched, are welcomed when they enter the church's doors. If there's a "growing edge," it would probably be the need to provide more opportunities for members and others to grow in their faith, i.e. Bible studies and Sunday School.

D. Describe the impact of the pandemic on your existing ministries and on any new ministries you started.

Antioch/Conway (276700): The main impact of the pandemic on existing ministries at Antioch United Methodist Church has been to limit the number of fellowship times the congregation has been able to have. Otherwise, outreach ministries, i.e. monthly collections of food items for CAP (Churches Assisting People) and collecting back-to-school supplies and hygiene items for Fostering Hope (a community store and outreach ministry in Conway), have continued.

New El Bethel (277101): New El Bethel United Methodist Church had not started any new ministries before the pandemic, and "existing ministries" that have been temporarily discontinued will resume once the pandemic has ended, ministries such as the monthly fellowship meals after church and the monthly Men's Fellowship Breakfasts. Outreach ministries, i.e. monthly collections of food items for CAP (Churches Assisting People) and collecting back-to-school supplies and hygiene items for Fostering Hope (a community outreach store and ministry), are continuing.

E. What ministries have you decided to keep and what ministries have you decided to let go of as a result of the pandemic?

Antioch/Conway (276700): Antioch United Methodist Church has not decided to "let go" of any ministries as a result of the pandemic, but the hope is to develop some new ministries once the pandemic has ended. Any ministries that have been "suspended" because of the pandemic will resume.

New El Bethel (277101): New El Bethel United Methodist Church is not planning to "let go" of any ministries. Those listed in Question D above, which have been temporarily "put on hold," will resume once the pandemic has ended.

F. In what ways are you uniquely equipped to meet the needs of the community?

Antioch/Conway (276700): Antioch United Methodist Church is "uniquely equipped" to meet the needs of the community because of it's visible location on a relatively busy "country" road and because those who attend are open and receptive to grow in the future.

New El Bethel (277101): Again, New El Bethel United Methodist Church is strategically located at a busy intersection in Conway, which makes the church "uniquely equipped" to meet the needs of the community. Also, the congregation at New El Bethel is mission-minded.

PASTOR'S REPORT Antioch/New El Bethel Charge 2021

The last year and a half have been "different" for the Antioch/New El Bethel Charge! The COVID-19 "pandemic" has impacted both Antioch and New El Bethel United Methodist Churches, and the impact has not been all that negative. While the "pandemic" has certainly affected attendance at both churches, and while we have had to curtail some fellowship opportunities from time to time, the members of the congregations are continuing to stay as "connected" as possible. (That's one advantage of being "small" and people knowing one another.) The faithfulness of both congregations has been especially evident in the level of their financial commitment to Christ and the Church. The receipts of tithes and offerings at both churches, especially this year, have been above average. If members are not attending the services because of the "pandemic," they send in their contributions. I am grateful for both congregations and their faithfulness in giving!

Since the Charge Conference last year and even during the "pandemic," both Antioch and New El Bethel managed to "hold" some events (with caution) along the way, including: several Men's Fellowship Breakfasts at NEB; a Service of Remembrance at the Antioch Cemetery; Christmas Lunch at NEB; Christmas Eve Communion at both churches; a seven-week Facebook Lenten Bible Study; Maundy Thursday Communion Services at both churches; an Easter Sunrise Service and Breakfast at Antioch; a few Antioch "Brotherhood" Suppers; a Mother's Day Breakfast at NEB; one Fellowship Supper and a few Youth Gatherings at Antioch; and A Day of Prayer and Appreciation for Law Enforcement at both churches.

One thing that impresses me about the Antioch and New El Bethel congregations is how open and receptive they are to outreach opportunities. They continue to bring food items for Churches Assisting People (CAP) every month, and the two churches came together again this year to collect back-to-school supplies and hygiene items for Fostering Hope, an outreach ministry in Conway. I'm sure that both congregations will reach out again at Christmas to a few families so they'll have a brighter holiday season. In 2020, Antioch and New El Bethel participated in Samaritan's Purse's "shoebox" ministry, and I'm thinking they will want to participate again this year.

It's hard to believe that Darrell Ricketts and I are in our fifth year as "partners in ministry" at the Antioch/New El Bethel Charge. God certainly "arranged" this partnership (through our District Superintendent) from the very start. I think Darrell would concur with me that God has blessed us (and our spouses) in many ways as we've served both Antioch and New El Bethel UMC's. The members of the two churches are so very loving and supportive of our ministry, and they demonstrate their gratitude to us and for us through their words and actions – and we thank God for them! We are excited about our ongoing ministry together at the Antioch/New El Bethel Charge!

Associate Pastor's Report Antioch/New El Bethel Charge October 3, 2021

As I reflect on the past year of ministry at Antioch and New El Bethel United Methodist Churches, I can't help but be filled with awe at God's power and providence in the face of what would seem like impossible circumstances. When we had our Charge Conference last year, we had been dealing with the pandemic for over six months, which seemed like a lifetime. We struggled to maintain church activities during a time when we couldn't gather, and any group activities were out of the question. Just when it seemed that things might return to some normalcy this year, we have been faced once again with a surge of the virus in our communities and several families have been touched by it, including our Senior Pastor. In spite of the difficulties, God has continued to guide the ministry of these two churches and allowed us to find new and positive ways to spread the Gospel and grow as a faith community.

We have continued to offer our worship services to members who are homebound through Facebook Live each Sunday. While we only livestream the service at New El Bethel, it is shared on the Antioch Facebook page and viewed by several hundred people weekly. We have continued "in-person" worship since we resumed during the summer of 2020, but attendance has continued to lag behind where it was prior to COVID. We have participated in several on-going mission projects, including collecting food for CAP (Churches Assisting People) in the Conway area every 2nd Sunday at both churches. We also have collected personal hygiene products and school supplies for the Fostering Hope Ministry in Conway which provides support to families offering foster care to children in need. We collected over 40 shoeboxes for Operation Christmas Child through Samaritan's Purse as a joint project for both congregations. We also supported Epworth Children's Home through both the Mother's Day and Workday offerings. During monthly communion services at New El Bethel, we collect an additional "helping hands" offering that is used to help individuals who frequently stop by our church on Sundays needing assistance. We also try to be sensitive to the special needs that may exist for our members and have taken up love offerings for individual members experiencing hardship during the pandemic.

Worship continues to be a vital part of our life together at both churches. We celebrated All Saints Sunday, not only recognizing the loss of members, but others who may have passed who held a special place in our hearts. It was especially meaningful to those who may have moved to the area and left family in other areas of the country. On December 13, 2020, we held our Luminary Remembrance Service at Antioch UMC Cemetery. It was outside and we practiced social distancing, but attendance was great. This annual celebration has turned into a meaningful event for not only our congregants, but the entire community. We held Christmas Eve Communion Services at both churches this year. Since there are two of us, Rev. Knight and I have begun alternating between the churches and offering Christmas Eve and Maundy Thursday Communion at both sites to allow greater participation. We held the Easter Sunrise Service at Antioch for both churches again this year, and breakfast was provided for all by the Antioch Men's Fellowship.

We have suffered some tremendous losses this year that have impacted us as congregations but also as individuals. Two members passed away at Antioch and three members at New El Bethel. One of the losses was due to the virus, which was devastating and unexpected. We also lost our oldest member at New El Bethel. While we know they have received their reward for lives well lived, our hearts still miss them. But in the shadow of this grief, we were also reminded of the newness of life as we celebrated the baptism of our youngest member at Antioch. We also celebrated the graduation of two of our youth and prayed with them as they look toward the future and what God has in store for them.

In closing, I must once again thank Rev. Knight for his tremendous leadership during this time and for his friendship, mentorship, and love. During my time as Associate Pastor at Antioch and New El Bethel United Methodist Churches, I have learned that "bigger" is not always better or even desirable when it comes to churches and that God truly honors His promise of "wherever two or three are gathered in my name, there I am in the midst of them". We have felt His presence and guidance regardless of our numbers and have seen His blessings as we have continued to have resources necessary for ministry. We look forward to the challenges that lie ahead with the assurance that "all things are possible through Him who loves us."

PASTOR'S REPORT Antioch/New El Bethel Charge 2022

I want to begin my 2022 Charge Conference Pastor's Report by saying once again what a joy and blessing it is to serve the Antioch/New El Bethel Charge alongside my friend and partner in ministry, Darrell Ricketts. We are in our sixth year together and continue to be excited about serving Antioch and New El Bethel United Methodist Churches. Both congregations show their love and appreciation to us in different ways, and we love and appreciate them so much as well! Darrell and I are so grateful for our shared ministry with them!

Of course, the last few years have presented some challenges for all churches because of the COVID pandemic, and that has proven true for Antioch and New El Bethel. I feel, though, that we have made some progress in getting back to a semblance of normalcy at the two churches, especially over the past year since our last Charge Conference.

We have been holding in-person worship services at Antioch and New El Bethel since June, 2020, and the service every Sunday at New El Bethel is on Facebook Live, which started during the pandemic. This ministry of having the services on Facebook Live has certainly benefited members of the churches who have been hesitant about returning and worshipping in-person, and there are a significant number of "views" for every service. The plan is to continue this ministry indefinitely! Attendance at the in-person worship services has not gotten back to pre-pandemic numbers, but members and friends of both churches have been very faithful in their stewardship. Antioch and New El Bethel are doing very well financially, perhaps better than ever!

We DID receive two new members into the fellowship of New El Bethel since last year's Charge Conference, which was a special blessing! On a different and sadder note, Antioch experienced the loss of five members, which is a large number for a small-membership church. With the growth in the Conway area, I hope that both churches will develop plans to reach out into the community and invite others, especially the unchurched, to come and find the warmth of Christian fellowship that they can offer. Again, we are gradually getting back to some normalcy at Antioch and New El Bethel. After the Charge Conference on October 3, 2021, monthly fellowship meals resumed at New El Bethel. Although participation hasn't been like it was before COVID, those who DO come to the meals really enjoy the food and fellowship – and they even seem to like occasional activities planned by the "Master Gamer," as I've been called by my "Junior" Pastor, ©! The monthly New El Bethel Men's Fellowship Breakfast also started back up and is attended by six or seven men every second Saturday morning.

At Antioch, several youth attend worship services there most Sunday mornings. Before the pandemic, Darrell and I met with the youth and their mothers regularly for food and fellowship together. We stopped those gatherings when COVID came, but thankfully, we've started them again. We had a Pool and Pizza Party recently for the youth, and we'll be making plans for the rest of the year with them. Like the folks at New El Bethel, the members of Antioch like to get together for good food and fellowship, too. We FINALLY were able to have a sub-sandwich supper and planning meeting in August (for the rest of the year).

Antioch and New El Bethel are both looking forward to having Homecoming this Fall, which is an event they've missed over the past couple of years. Also, they "joined forces" a month or so ago in collecting hygiene items and school supplies for Fostering Hope, a ministry that helps fostering families and children in the Conway area. Each church collects non-perishable food items and other needed items monthly for another Conway ministry, CAP (Churches Assisting People). The two congregations are always willing to "reach out" to others in their times of need!

I haven't mentioned some other activities at the churches or improvements or "face-lifts" that have been made to their facilities, but I simply want to say that the Antioch and New El Bethel folks are VERY SPECIAL people! Again, Darrell and I love and appreciate them so very much and look forward to some ongoing and fruitful ministry together!

ASSOCIATE PASTOR'S REPORT Antioch/New El Bethel Charge 2022

It seems unreal that Dickie and I are in our sixth year serving the Antioch/New El Bethel Charge. The past six years have been filled with many challenges as we have dealt with the pandemic and several deaths, but they have also been filled with enormous blessings for which we are both thankful.

This past year has allowed us to return to some degree of normalcy, yet it seems we have a way to go to get back to the activities and participation we experienced before the pandemic. Our worship services are traditional and well received by the members, but the lack of a musician has presented challenges in planning since we are limited to what's available in recorded form. I continue to record the music for all of our services and provide the bulletins for Antioch each Sunday. This seems like a small part of our ministry, but one I hope is an example that God uses us all in small ways to support the overall ministry of the church.

I am especially happy with our ability to offer special services at both churches during Lent and Advent. During Lent, our Ash Wednesday Services have been well received as well as our Maundy Thursday Services. We rotate each year between the churches and strive to create intimate experiences unique to each congregation. During Advent, we have celebrated Christmas Eve at both churches with special Communion services. In addition, we have established the tradition of a Candlelight Service at the Antioch Cemetery that has been well received by the community. We have added Children's Moments to our services at both churches to meet the needs of our families with small children. We have plans to start Children's Church at New El Bethel this fall. Both churches are having Homecoming Services this fall, something that has not occurred in the past three years.

Both churches continue to support their communities through mission projects. On the second Sunday of each month, we collect food donations for CAP (Churches Assisting People), a multi-denominational ministry in the Conway area. We also adopt families at Christmas and continually seek to support individuals in need. At New El Bethel, we plan to return to having our Winter Coat Give-Away this fall. We are working with the youth at Antioch to identify mission projects they can do as a part of our youth fellowship. We have collected personal hygiene items and school supplies for Fostering Hope, a ministry in Conway that supports foster children and their families. Both churches are full of the love of God and show it through their actions.

We are proud of both churches and their financial support of the ministry. Both have paid 100% of their apportionments each year and will do the same this year. They have identified needed maintenance on their facilities and completed several projects including: Antioch UMC – new letterboard sign, replacement of HVAC system, repaired roof leaks, painted the ceiling, and completed a survey of the cemetery; New El Bethel UMC – painted exterior trim and working to replace the roof damaged by hailstorm.

Loss of several long-time members at both churches has been difficult, but we have celebrated their lives with assurance of their salvation. It will be important for both churches to develop plans to reach out in their communities and invite others to join our church families. With the tremendous growth in Horry County, there is no doubt that the harvest is plentiful.

I would be remiss if I didn't mention the pastoral care provided by Dickie and the impact it has had on the lives of our members. Since I am still working full-time, he continually follows up with members who are shut-in as well as regulars who miss services. He communicates our love for them and keeps me well informed on how everyone is doing. While some may worry about numbers, he reminds me that ministry is about people, and we strive to support the members of these two congregations with love, prayers, and spiritual guidance. I look forward to continuing to learn from Dickie and believe that God will continue to bless our ministry together.

What a privilege and blessing it has been to serve the Antioch/New El Bethel Charge alongside my friend and partner in ministry, Darrell Ricketts, for the past six years! As we continue through our seventh year together in ministry with these two wonderful congregations, we are excited about everything God has in store for us. We continue to receive much love, care, and appreciation from the folks at both churches, and we try to let them know how much they mean to us as well. Darrell and I are so grateful for our shared ministry with them!

Over the past year, we have been continuing through a few post-COVID pandemic struggles at Antioch and New El Bethel. Attendance at Antioch is close to where it was before the pandemic, but at New El Bethel, we are not reaching the average of forty or so persons in attendance as we were doing before COVID hit. There's good news, though! Both churches did well financially through the pandemic, and we continue to experience good giving at both churches, thanks to the faithfulness of the people. We are grateful!

One blessing that came out of the pandemic time is that a Facebook Live service began at New El Bethel and continues to this day. Horry County and the Conway area are growing, so maybe we'll be able to "latch on" to this growth and attract others to our worship services and our times of fellowship at Antioch and New El Bethel. Both congregations certainly have some potential to experience numerical and spiritual growth in the years ahead. Hopefully, Darrell and I can encourage and promote a positive attitude among the members of the two churches about "making disciples of Jesus Christ for the transformation of the world"!

As I bring this relatively brief Pastor's Report to a close, I want to say that the Antioch and New El Bethel folks are VERY SPECIAL people to Darrell and me! ASSOCIATE PASTOR'S REPORT Antioch/New El Bethel Charge 2023

Rev. Knight and I are beginning our seventh year of service to the Antioch/New El Bethel Charge. The past six years have been filled with many challenges as we have dealt with the pandemic and several deaths, but they have also been filled with enormous blessings for which we are both thankful.

As I look back on our ministry this year, it seems our work has been overshadowed by the current upheaval in the United Methodist Church. When the Conference released its guidelines for disaffiliation in December, we were faced with the challenge of how to adequately present the issues to these two small congregations and what would be the best way to guide them towards their future ministry. When the deadline of March 1 was communicated by the Conference for any seeking to disaffiliate during the Summer Conference this year, we knew that it would be impossible to do an adequate job of allowing the members to become familiar enough with the issues on both sides and also sort through the financial requirements set forth by the Conference. We decided it would be best to advise both congregations to begin the discernment process in January 2023 and continue it until January 2024. To this point we have presented information on the issues. including the viewing of videos by both Rob Renfroe and Adam Hamilton. We have been careful not to tell the members how they should feel or vote but to allow them to discern the direction the church should take. The discussions thus far have been cordial and open to how each individual member feels about the issues. We have scheduled a straw poll to be taken by the first of September to determine the direction they are headed in and what steps should be taken next.

While the discernment process seems to have monopolize much of our time, both congregations have continued in various ministries to serve others. Rev. Knight continues to lead and inspire members to show love in various ways to each other and their fellow man. I am fortunate to serve with him and be mentored by him in working at these churches. Several times throughout the year both congregations have partnered with the Fostering Hope ministry in Conway in collecting items for foster children in the area. We have collected school supplies as well as personal hygiene items for these students. One of our members, Lee Ellis, and his family

sponsored a fundraiser for a young man involved in a boating accident in the area. Although we only have a few children in these small churches, we have offered children's moments during the morning worship, and at New El Bethel, we have volunteers who hold Children's Church to engage children attending in ageappropriate activities.

We continue our monthly fellowship meals at New El Bethel and our quarterly birthday celebration meals at Antioch. These have been opportunities to have open discussions about disaffiliation and strengthen the "ties that bind". We continue to offer monthly fellowship gatherings for our young adults at Antioch as well as a monthly Men's Group at New El Bethel. Rev. Knight provided Facebook Live Bible Studies during both Advent and Lent which were viewed by not only our members, but others in the community.

Personally, I retired from full-time teaching in January 2023, which has allowed me to focus on completing the Course of Study classes. At present, I have four more of the basic classes to complete. I plan to complete them this year through Duke. These classes have broadened my knowledge of professional ministry and I hope that the things I learn will allow me to serve God and my fellow man better.

As both churches approach a decision on disaffiliation, I too must discern the direction God is leading me. As I said at our last discernment meeting at New El Bethel, I don't think the most important question facing these two congregations right now is whether they stay UMC or disaffiliate. I think the most important question is - Where is God leading them in ministry? How can they engage in meaningful ways with their communities that shines a bright light of hope and salvation so that others want to be a part of it? The life of these two churches is not dependent on the sign or emblem on the building, but the fire burning in their hearts for Christ and their fellow man.

Members of New El Bethel United Methodist Church first started meetings on January 15, 2023 for the purpose of presenting both sides of the Discernment Process. We had seven Church Council Meetings during the year and had a "Straw Vote" on August 8, 2023. The vote was to disaffiliate from the United Methodist Church. We watched videos on staying with the United Methodist Church presented by Adam Hamilton and videos on going with the Global Methodist Church presented by Bob Renfroe. We had a pastor from Georgetown, Rev. Steve Garner, discussing some of the things his churches had done to leave the United Methodist Church. Rev. Garner answered questions about the process they went through.

In addition, we had various meetings of our Finance Committee, Membership Committee, and consulting with attorneys during this process, as well as a few other committee meetings. The members have prayed collectively and independently for God's will to be done during this process
